6. *The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 PM on 14th May 2018 at the office of Bheemdatt Municipality, Office of Municipal Executive, Kanchanpur, Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. 45,000.00, which shall be valid for 30 days beyond the validity period of the bid.
